## 2021 Energy Star Refrigerator Rebate Program

Central Electric Cooperative (CEC) members can receive a \$50 rebate for the purchase of an Energy Star rated refrigerator. The current rebate program is for refrigerators purchased Jan. 1, 2021 or later.

Members can verify Energy Star status by visiting the Energy Star website at [www.energystar.gov](http://www.energystar.gov). Select “Refrigerator” and filter by model number to determine if your model is Energy Star.

### Program Procedures and Requirements

- *Appliance model number must be found on Energy Star website ([www.energystar.gov](http://www.energystar.gov)) to be eligible for rebate.*
- Purchase date must be Jan. 1, 2021 or after.
- One rebate type per account.
- Appliance must be installed within CEC’s service territory.
- Must include a copy of the original, dated sales receipt with application.
- Incomplete applications and documentation will not be processed.
- Members are responsible for proper disposal of preowned appliance.
- Qualifying refrigerators must be 10 cubic feet or larger. Cannot be a compact (mini) refrigerator.
- CEC reserves the right to inspect the member’s home for installation of materials listed on the application. The rebate may not be issued if CEC cannot verify the information provided.
- After all program requirements are met, a rebate in the form of a check will be issued to the member. Please allow 6-8 weeks after the receipt of all documents for the check to be received.
