2019 Heat Pump Rebate Program

Central Electric Cooperative (CEC) members can receive a \$200 rebate for installing an Energy Star certified heat pump. Systems must have been purchased Nov. 1, 2018 or later for the 2019 rebate program.

Rebates are available for the following heat pumps:

- Air Source Heat Pump
- Ductless Mini-Split Heat Pump
- Geothermal Heat Pump

Members can search for Energy Star certified systems by visiting the Energy Star website at www.energystar.gov. You can verify a system is Energy Star rated by visiting www.ceedirectory.org and selecting your particular heat pump category. Once on the category page, enter the AHRI Certified Reference Number supplied by your installer.

To receive the rebate CEC must receive:

- ✓ Completed rebate form.
- ✓ Sales receipt indicating the type of system, installation date, purchase price, and model numbers.
- ✓ An AHRI *Certificate of Product Ratings*, which must include unit model number, capacity, and efficiency performance ratings. System must be Energy Star certified to qualify for rebate.

Program Requirements:

- One rebate per account.
- Install date must be Nov. 1, 2018 or after.
- Systems must be installed within CEC's service territory.
- Application must be filled out completely. Incomplete forms will not be processed.
- CEC reserves the right to inspect the member's home for installation of materials listed on the application. The rebate may not be issued if CEC cannot verify the information provided.
- After all program requirements are met, a rebate in the form of a check will be issued to the member. Please allow 4-6 weeks after the receipt of all documents for the check to be received.
