2019 Appliance Rebate Program

Central Electric Cooperative (CEC) members can receive a rebate for installing the following Energy Star rated appliances. Appliance must have been purchased Nov. 1, 2018 or later for the 2019 rebate program. Members can verify appliances by visiting the Energy Star website at www.energystar.gov. Select the category “Energy Efficient Products” and locate your particular appliance. Use the “Product Finder” tab to enter the exact model number. Model numbers listed in the search are qualified.

Rebates are available for the following:

Refrigerator:	\$100	Dishwasher:	\$25
Freezer:	\$50	Window Air Conditioner:	\$25
Clothes Washer:	\$50	Dehumidifier:	\$25
Electric Clothes Dryer:	\$50	Mini Compact Refrigerator:	\$25

Program Procedures and Requirements:

- *Appliance model number must be found on Energy Star website (www.energystar.gov).*
- One rebate per appliance per account.
- Each member will be eligible for a maximum of \$200 in appliance rebates per calendar year.
- Purchase date must be Nov. 1, 2018 or after. The prior rebate program ended Nov. 15, 2018.
- Appliance must be installed within CEC’s service territory.
- Members are responsible for proper disposal of preowned appliance.
- Application must be completely filled out. Incomplete forms will not be processed.
- Include a copy of the original, dated sales receipt.
- CEC reserves the right to inspect the member’s home for installation of materials listed on the application. The rebate may not be issued if CEC cannot verify the information provided on the application.
- After all program requirements are met, a rebate in the form of a check will be issued to the member. Please allow 4-6 weeks after the receipt of all documents for the check to be received.
