## Our "Eggs" are in More Than One "Basket"

I recently received an email question through our new "Ask Matt" feature on the banner of our website. This is another convenience allowing you, our members, to reach out directly to me with questions. We have a similar feature on our internal website so employees can do the same.

The question I was asked concerned the interconnection of renewable power supply sources to the grid through Central Electric Cooperative's (CEC's) system. We have, for many years, had a program that assists members who want to install alternative generation, typically solar or wind, and connect to our system. We have been able to work with our power supplier, Allegheny Electric Cooperative (AEC), to provide information and some financial assistance to help with these projects. This question brought to mind a couple of things.

First, with various incentives being discussed at the state and federal levels, more of these projects may be on the horizon. This makes our program that much more important. It allows CEC to offer an alternative to our members who are interested in the diversity of renewables, without impacting those members who are not. Let's call this our "renewable portfolio basket."

Second, and probably more immediate, is our power supply makeup. CEC and all Pennsylvania Rural Electric Association (PREA) members (14 cooperatives in Pennsylvania and New Jersey) own the Allegheny Electric Cooperative (AEC) in the same manner that CEC members own CEC. We have a long-term, full-requirements contract with AEC to provide all of our power supply and transmission services. One of

CEC's board members represent CEC's interests on the AEC board, providing member ownership and local control. AEC owns the Raystown Hydroelectric Facility and a stake in Susquehanna Nuclear Facility. These two sources represent about two-thirds of PREA's cooperatives' power supply. The other third comes from a combination of long- and short-term contracts with various suppliers in the marketplace. This diverse approach to meeting our power supply needs reduces our risk and provides rate stability. While I would call this our "diverse power supply basket," it should be noted that the Raystown Hydroelectric Facility is considered a renewable resource. And, in an era when coal plants are being closed, Susquehanna Nuclear Facility has no carbon footprint. This makes our supply that much more viable and insulates CEC from further risk.

The last "basket" I would like you to consider in the power supply picture is demand side management. As I have said in previous articles, the cheapest kilowatt is the one you don't have to buy. CEC has had load control programs in place for many years. These programs include the "Peak Alert" notifications you hear during the summer asking you to voluntarily curtail unnecessary electric usage during times that the demand on the grid is its highest. CEC also actively controls water heaters and electric heat systems to shave energy use peaks. Both programs are voluntary. Both avoid

the purchase of some of the most costly kilowatts, providing a benefit to the grid, and our members' pocket books. We also offer home energy audits and discuss energy use with all members to help them use less energy. I know it may seem contrary for us to try to sell less of the product we provide but it is in your best interest — so it is also in ours.

As you can see, we take a "many eggs in many baskets" approach to meeting your electricity needs. In this way, we are able to manage both cost and risk while offering a variety of services to our members. If you have any questions about our approach or the programs we offer, please don't hesitate to let us know.

May is notorious for storms and power outages. It is also National Electrical Safety Month. So this month we will talk about being safe during power outages. Many members utilize an emergency generator to power their home's breaker box during an outage. But you need to be careful of a dangerous situation called "backfeeding." Backfeeding is when your generator power flows back onto power lines, endangering line workers making repairs. A transfer switch guards against backfeeding. Installation requires a certified electrician and an electrical inspection.

CEC can install a Generlink<sup>™</sup> transfer switch on your meter to provide a path for power from your generator to your home's breaker box, while guarding against backfeeding. Installation takes 10 minutes and does not require an inspection. We provide a 20-foot cord to link your generator to the Generlink<sup>™</sup>.

#### Generlink<sup>™</sup> Transfer Switch

Generlink<sup>™</sup> has an indicator light that notifies you when power from the cooperative is lost. This same light informs you when power is restored. You can also purchase a Generlink<sup>™</sup> with built-in surge protection for an additional fee.

Before ordering a Generlink<sup>™</sup>, make sure you know the running output of your generator. Also find the exact designation of the 4-space female receptacle located on the generator face plate. Designations range from L14-20, L14-30 or L14-50. Both pieces of information are required to make a Generlink<sup>™</sup> match your needs.

Now you are ready to safely use a generator to provide electricity during outages. Remember to always place your generator outside your home to avoid carbon monoxide poisoning or fire hazards. All thunderstorms producing lightning are dangerous. A Thunderstorm Watch means a thunderstorm is possible for your area. A Thunderstorm Warning means a thunderstorm is taking place in your area. If you can hear thunder, you are in danger from lightning. Lightning kills 75 to 100 people each year, and outdoors is the most dangerous place to be. The following safety tips will help you stay safe outdoors during a thunderstorm.

- Look for darkening skies, flashes of lightning or increasing winds. Lightning often precedes rain, so don't wait for the rain to begin. If you hear thunder go to a safe place immediately.

- The best place to go is a sturdy building or car,

but make sure the windows in the car are shut. Avoid sheds, picnic areas,

baseball dugouts and bleachers.

- If there isn't a shelter around you, avoid trees. Crouch down in the open area, and keep twice as far away from a tree as it is tall.

- Stay out of water.

- Avoid metal, clotheslines and fences. If you are carrying a backpack, leave it, because they often have metal in them.

- If you're doing an outdoor activity, wait at least 30 minutes after the last observed lightning strike or thunder before resuming.

### **Recipe of the Month**

## **Black Bean Salsa**

#### **Ingredients:**

- One 14-ounce can black beans, drained
- One 14-ounce can corn, drained
- 1 purple onion, finely chopped
- 1 fresh jalapeno, seeded and chopped
- 4 Roma tomatoes, chopped
- One 8-ounce jar chunky salsa
- 1/4 cup balsamic vinegar
- 1/4 cup olive oil
- Salt & pepper to taste
- Cilantro, chopped, to taste
- 4 to 5 green onions, chopped with tops

**Directions:** Mix all ingredients together several hours before serving. Serve with tortilla chips (lime salted chips are good).
