

I was recently at the National Rural Electric Cooperative Association (NRECA) regional meeting representing Central Electric Cooperative (CEC) along with several of our board members. These meetings can be quite informative with a combination of general and breakout sessions that allow participants to hear speakers on a wide variety of topics. This year's topics included cyber security, generational communication in the workplace and rural broadband, just to name a few. However, the intent is always the same, to provide cooperatives with a look at what is being done throughout the country, identify best practices and give examples of how each cooperative may choose to incorporate these into their own organization.

Home Heating Safety

Heating equipment is a leading cause of home fires during colder months. Two out of three reported home heating fires, and associated deaths and injuries, involve portable and fixed space heaters and related equipment, such as fireplaces and chimneys. The following tips will help keep you and your household safe this heating season.

Portable Heaters:

- When shopping for a portable heater, choose a model with temperature control, automatic shut-off, and a seal of approval from an independent testing laboratory, indicating it has met basic safety standards.
- Keep portable heaters three feet away from anything that can burn.

Fireplaces and Wood Stoves:

- Always use a fire screen to contain sparks.
- Never burn garbage or waste materials.
- Make sure anything flammable is kept a safe distance away from the fireplace.

Food For Thought:

- If a fire occurs in your home, a working smoke alarm can save your life.
- Everyone in your home should know what to do in the event of a fire. Plan and practice a home escape plan.

Appliance Rebate Program a Success!

CEC's Appliance Rebate Program was a huge success! We issued 171 rebates from Jan. 1 to Aug. 26, 2016. Members saved money on the initial appliance purchase and will continue saving monthly with a more efficient unit.

Bright Ideas Teacher Grants Available

Bright Ideas Teacher Grants Program encourages innovative, energy-related learning projects that go beyond available school funding. Teachers, K-12, from schools within Armstrong, Butler, Clarion, Forest and Venango counties are eligible. Schools do not need to receive electric service from CEC. Home school teachers are also welcome to apply. The maximum teacher grant will be \$1,000 per award period and given to the school (individually awarded to home school teachers).

Topics must be energy related. They must directly involve students with goals clearly defined and measurable. Some typical topics may include renewable energy; energy generation; energy use,

efficiency, conservation, safety; and what is an electric cooperative. The school principal must approve project.

Recipe of the Month

Sweet Potato Casserole

Casserole Ingredients:

- 29-ounce can sweet potatoes (do not drain)
- 3/4 stick margarine or butter, melted
- 1/2 cup sugar
- 1/2 teaspoon nutmeg
- 1/4 cup brown sugar
- 2 eggs
- 1/2 teaspoon cinnamon

Directions: Heat oven to 400 degrees. Warm potatoes in the juice from the can. Mash to a very smooth consistency using a mixer. Add other ingredients and mix well. Place in 2-quart casserole dish. Bake for 20 minutes.

Topping Ingredients:

- 3/4 cup corn flakes
- 1/2 cup chopped nuts (pecans or walnuts)
- 1/2 cup brown sugar
- 3/4 stick melted margarine

Directions: Mix ingredients together. Spread on casserole and bake for another 10 minutes.
