Rate Caps, Deregulation and You

Much has been discussed in the local news about electric rate cap removal and rising electricity costs. So how does this affect you as a CEC member? Fortunately it affects you very little. Surrounding electric utilities have had their generation rates (the cost to produce the energy at a power plant) "capped" since 1999. That was the year that Pennsylvanians could shop for a better electric generation price. Because your cooperative is not under the jurisdiction of the Pennsylvania Public Utility Commission (PUC) your generation rate has always been at market price.

CEC charges a generation rate of \$0.067 per kilowatt-hour (Price-to-Compare on your electric bill). If another supplier offers you a price lower than that, by all means choose what makes economic sense.

Unfortunately, no electric supplier has signed a contract to sell to our members. It might be so because our supplier, Allegheny Electric Cooperative in Harrisburg, Pa., has

worked hard to provide you with a competitive rate.

So if you receive information in the mail, or a phone call at dinner time soliciting your interest in switching to another generation supplier, contact us at 1-800-521-0570, ext. 2172 to find out if that company has a contract with your cooperative. Please be assured that when another supplier does so, we will post this information on our Web site at www.central.coop as well as in Power Lines. So let the phone ring ... and enjoy that second piece of pie!

Are You Interested in a CEC Director's Seat?

CEC's Board consists of eight directors. Each year two directors are elected from the cooperative membership, giving each elected director a four-year term. Director seats are divided among counties the cooperative serves. This year, resident members from Forest and Venango counties are invited to petition for these two respective seats. To be eligible for director nomination, a member must be a permanent resident in the county of an aforementioned respective seat as well as meet other qualifications provided in the cooperative bylaws.

Members interested in receiving a qualifications list and petition should submit the following coupon no later than April 1, 2011. A list of qualifications along with a petition form will be mailed immediately. Interested members meeting the qualifications should then send a written request (including the interested member's full name, address, telephone number, county of residence and account number) along with a completed petition signed by 20 cooperative members, to the nominating committee at the address provided by May 1, 2011.

In accordance with its bylaws, the cooperative has a process to ensure petitioning members are qualified prior to becoming director nominees. Each year the cooperative board selects a nominating committee which is responsible for determining whether each

petitioner meets the qualifications. The committee reviews the petitions and schedules interviews with each prospective nominee. The committee then submits a list of the eligible candidates for placement on the ballots.

Nominee names, along with a photo and background information, are presented in the July issue of Power Lines. At this time cooperative members are invited to vote by mail or via Internet prior to the Annual Meeting. Members may also vote by paper ballot on the day of the meeting prior to the meeting's commencement. The final election results will be announced prior to adjournment.

Low-Hanging Energy Savings

All of us want to save energy. But most of us do not have a bag full of money required to make a huge investment. Here are some low-cost and no-cost ways to assure energy savings. These will not cut your energy bill in half, but over a year the savings add up:

- Install compact fluorescent bulbs (CFLs). They use 1/5 the energy of regular bulbs (choose the 23-watt variety).
- Lower the water heater to 120 degrees Fahrenheit.
- Insulate your hot water lines in an unconditioned basement.

- Clean or replace your furnace filter once a month.
- Caulk and seal all leaks in your home (windy days help to find them).
- Wash laundry in cold water.
- Hang clothes in basement (if heated) in the winter.
- Clean refrigerator and deep freezer coils at least once a year.
- Install a programmable thermostat on your furnace.

Fireplace Safety Tips

Fireplace safety is extremely important. The following safety tips are for both wood burning and gas fireplaces:

- Open the damper before starting a wood-burning fire.
- Keep chimney and roof top clear of debris.
- Use a chimney cap.
- Have your chimney inspected annually.
- Do not burn trash in your fireplace.

- Do not use lighter fluid to start a fire, use long matches instead.
- Do not use charcoal in your fireplace to avoid carbon monoxide poisoning.
- Keep decorations and flammables away from the fire.
- Teach children about fire safety.
- Never leave a wood-burning fire unattended.

Recipe of the Month

Warm Winter Lemon Cake

Ingredients:

- 1 box yellow cake mix
- 2 (4 ounce) serving size boxes of instant lemon pudding
- 2 cups milk
- 1-1/4 cups water

Directions:

1. Mix 1 box yellow cake mix according to package directions.
2. Pour into a greased 9 X 13 inch cake pan. Set aside.
3. Pour milk and water into a large bowl and add instant lemon pudding mix.
4. With a wire whisk beat for 2 minutes. Pour over cake. (Place cake pan on cookie sheet to catch spills as it bubbles.)
5. Bake at 350 degrees Fahrenheit for 55-60 minutes. Let set 20 minutes before serving. Top with raspberries or cool whip.
