For many years we have performed regular membership surveys to help ensure that we are meeting your expectations. We ask questions pertaining to our performance in important areas such as customer service. reliability and rates. We have been tracking the results to help us identify what we are doing well and where we need to improve. Overall, we have been trending in a positive direction. In fact, our most recent survey resulted in our highest score ever. The members ranked us higher than our investor-owned neighbors and higher than our cooperative counterparts. As you can imagine these results are what we strive for and are a great affirmation of the direction we are headed. More importantly, we recognize this is just a start and

these results drive us to find new and better ways to continuously, incrementally improve our performance.

CEC is looking for members to serve on the 2012–2013 MAAC committee. The committee is designed to establish effective communication between cooperative members, the board of directors and management.

As a MAAC member you have the opportunity to discuss and contribute your ideas on issues directly concerning cooperative members. You will also have the chance to submit recommendations to the board of directors and management on improving services and procedures. The committee will meet eight times (once a quarter) throughout the 2012–2013 term.

A typical 2,000–square–foot home with average insulation will consume about 70 million Btu (British thermal units) during the winter. Here is an estimate of the total cost to heat an average home, based on local heating fuel costs for 2011–2012:

### **Propane Furnace**

\$40/million Btu (\$3.30/gallon) \$2,800/season Oil Furnace (\$3.60/gallon) \$33/million Btu

### **Recipe of the Month**

#### **Sweet Potato Casserole**

### Ingredients:

- 1 large can (29 ounces) sweet potatoes
- 3/4 stick margarine or butter, melted
- 1/2 cup sugar
- 1/4 cup brown sugar
- 1/2 teaspoon cinnamon
- 1/2 teaspoon nutmeg
- 2 eggs

### **Directions:**

- 1. Warm potatoes in the juice from the can.
- 2. Mash to a very smooth consistency using a mixer, blender or food processor. Add other ingredients and mix well.
- 3. Place in 2 quart casserole dish.
- 4. Bake uncovered for 20 minutes at 400 degrees Fahrenheit.
