The Best of Plans

Planning a vacation can be a lot of fun. Planning for your childrens' education is perhaps a little intimidating. Planning a move across the country is something I am trying to forget. Planning in the electric distribution utility business can make them all seem pretty simple. There are a lot of "moving parts" when we consider Central Electric Cooperative's (CEC's) future.

CEC, like all electric utilities, spends a lot of time making plans for our members' future needs. Because of the great experience of the many qualified employees, those plans are often executed exactly as we would expect. We tend to plan very conservatively so that we will remain a healthy and viable organization well into the future.

The first quarter of the year is often spent reviewing the past year and planning for the future. Here at CEC, we spend October and November creating and presenting

the upcoming year's budget for our board to review and approve. With that process we begin the review of our rolling three-year strategic plan. We spend the time during budget season looking at the year we are completing to see what we have accomplished, what needs rebudgeted for the upcoming year and how we need to adjust priorities. To begin the new year we present to our board the yearend financials and the results of our strategic plan from the year past. We will also revise the strategic plan to reflect those priorities previously mentioned, and to add the new third year to our rolling three-year plan. In this case 2012 will be wrapped up, and 2015 will be added. The idea in all this is that we make continual progress, maintain continuity and still remain flexible enough to correct our course, if necessary.

The past year has been a challenging one. The year 2012 saw the completion of major system improvements and the construction of our new office facility. We have reached many of our target milestones. We experienced a very volatile weather year, electric generation interruptions and lowerthan-normal sales. (I'll bet you are thinking that I am preparing you for bad news, but I am not.) Despite these concerns, the cooperative remains a financially sound organization, meeting all of our required debt service requirements while maintaining our target equity, as prescribed by our board. We will once again be allocating and retiring patronage capital to our members. As I have previously mentioned, our capital credit retirement for 2012 will coincide with the closings of the books and subsequent audit so that the allocation and retirement are based on actual, rather than estimated, numbers. Additionally, we began 2013 with no rate increase. In the interest of full disclosure, we will continue to monitor our financial condition closely and consider a rate change if conditions warrant.

Our planning approach has allowed CEC to maintain a balance between reliability, rates

and financial stability. The year 2012 was not the financially positive year that we projected for many of the reasons listed above. However, because we took those things that are out of our control into account, we still exceeded our requirements. As we look at our 2012 numbers, I reflect on a question that recently retired Director Bob Sterrett asked me last year. That question was "Are you satisfied?" The context of the question was during my annual performance evaluation after a pretty strong year for our company.

My response then, as it is now, is that while I am pleased with the efforts and performance of our organization, I am never satisfied. I believe it is important to identify problems and work to resolve them, celebrate successes and look to build on them. However, the moment you believe you are done, you begin to fall behind. So we continue to make our plans, control what we are able and adjust to what we are not. We will continue to solicit your input and do what is needed to maintain the service you expect.

Are You Interested in a CEC Director's Seat?

As a CEC member you have a voice in who serves on our eight-member board of directors. Every year members elect two directors, giving each director a four—year term. Director seats are divided among counties the cooperative serves. This year, resident members from Clarion and Venango counties are invited to petition for these two respective seats. To be eligible for director nomination you must have a permanent residence in that county and meet other qualifications required by your cooperative's bylaws.

To receive a qualifications list and petition, please submit the following coupon by April 1, 2013. If you meet the qualifications you will send a written request (including your full name, address, telephone number, county of residence and account number) along with a completed petition signed by 20 cooperative members, to the nominating committee at the address provided by May 1, 2013.



After the cooperative confirms your eligibility, you will visit the CEC office to attend an orientation meeting and meet with the nominating committee for an interview. The committee then submits a list of the eligible candidates for placement on the ballot.

Nominee names, along with a photo and background information, are presented in the July issue of Power Lines. Cooperative members will vote by mail or internet prior to the Annual Meeting, or vote by paper ballot on the day of the meeting on Aug. 23, 2013, prior to the meeting's commencement. The final election results will be announced prior to adjournment.

Your board of directors has appointed a nominating committee to review prospective candidates interested in running for CEC director.

Forced-air heating systems are the numberone choice for many members. The greatest way to save on heating costs is to turn back the thermostat while sleeping or away from home. The U.S. Department of Energy recommends setting back the temperature by 10 degrees for at least eight hours. The results will yield a 5 to 15 percent reduction in heating costs.

A common misconception is that the energy used to reheat a cold house is greater than the energy consumed maintaining a desired temperature. This misconception has been dispelled by years of research and numerous studies. Your furnace's output is constant, so the total energy used depends on how much heat the home is giving off that must be replaced. A cold house gives off less heat than a warm one. The long time your furnace runs to reheat your house may feel wasteful but is canceled by the long time the furnace is off when the house cools down. So the longer your house remains cool, the more you save.

Furnace Savings

A programmable thermostat is the easiest choice for getting the job done. They are available in digital or electromechanical formats. And if you don't want to spend the money on one, manually turning back your thermostat will also work. Please note that setting back the thermostat by more than 2 degrees is not recommended for heat pumps, resistance heating, boilers or radiant floor systems.

Finally, placement of your thermostat can affect performance. Place thermostats away from direct sunlight, drafts, doorways, skylights and windows. It's never too late to make some small changes to save money over the long haul. Stay safe and warm this winter season by turning down to save up!



- Secure electrical and phone cords out of traffic areas.
- Install handrails on all stairways.

- Use a sturdy stepstool when climbing or reaching for high places

- Never stand on a chair, table or surface on wheels.
- Arrange furniture to provide open pathways to walk through.

- Remove fallen leaves or snow from outdoor walkways.
