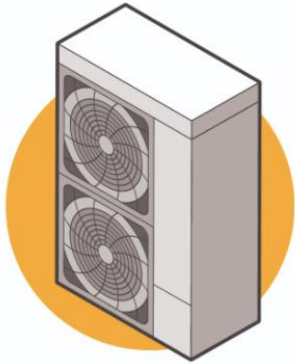




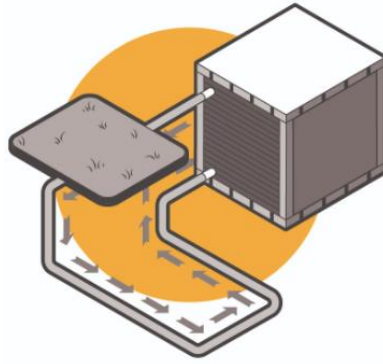
## Heat Pump Rebates

Central Electric Cooperative (CEC) members are eligible to receive a rebate for the installation of a new efficient heat pump. The current program is for eligible heat pumps installed Jan. 1, 2022, or later.

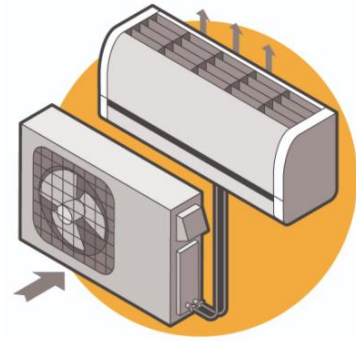
### Rebates are available for the following heat pumps:



**Air Source Heat Pump**



**Geothermal Heat Pump**



**Ductless Mini-Split Heat Pump**

Heat Pump Type	Minimum Requirements	Rebate
Geothermal Heat Pump	Must be Energy Star Certified	\$300
Air Source Heat Pump	HSPF $\geq$ 8.5 and SEER $\geq$ 15 and EER $\geq$ 12	\$150
Ductless Mini-Split Heat Pump	HSPF $\geq$ 8.5 and SEER $\geq$ 15 and EER $\geq$ 12.5	\$100

HSPF: Heating Seasonal Performance Factor; SEER: Seasonal Energy Efficiency Ratio; EER: Energy Efficiency Ratio

Members can verify a heat pump's qualifications by visiting [www.ahridirectory.org](http://www.ahridirectory.org) and searching by the AHRI Certified Reference Number (certification number supplied by the installer) or the product's model number. Energy Star status of geothermal heat pumps can be verified at [www.energystar.gov](http://www.energystar.gov). Select "Product Finder" and search by category.

### Rebate Program Requirements

- Maximum of one heat pump rebate per account.
- New unit must be installed Jan. 1, 2022, or after.
- Must be installed within CEC's service territory.
- Copy of AHRI Certification must be submitted with application.
- Incomplete applications and documentation will not be processed.
- CEC reserves the right to inspect member's home for installation of unit listed on application. Rebate may not be issued if information provided cannot be verified.
- Allow 6-8 weeks after the receipt of all documents for the rebate check to be received.

## Heat Pump Rebate Application

To receive rebate, the following must be provided to CEC:

- ✓ Completed rebate application.
- ✓ Dated sales receipt or installation agreement indicating type of unit, installation date, and model numbers.
- ✓ An AHRI *Certificate of Product Ratings*, which must include unit model number and efficiency performance ratings, including HSPF, SEER, and EER.
